#### **GRIFFITH COUNCIL NEWS – DECEMBER 2019**

#### **CHANCELLOR'S REPORT**

The Chancellor updated members about the following matters:

- Naming ceremony Ian O'Connor Building (G40) Gold Coast campus
- December graduation ceremonies
- 2020 National Conference on University Governance
- Independent review of effectiveness of Council

#### **VICE CHANCELLOR'S REPORT**

The Vice Chancellor presented her <u>December</u> Report to Council and highlighted the following matters:

- Griffith's excellent scholarship outcomes: nine New Colombo Plan Scholarships; a Schwarzman Scholarship, and four Fulbright Scholarships.
- Classification of the Gold Coast as a regional centre an excellent outcome for Griffith.
- Successful launch of Creating a Future for All: Strategic Plan 2020-2025.
- Temporary reinstatement of designated smoking areas on the Mt Gravatt, Nathan and Gold Coast campuses to address the risk caused by people smoking in bushland areas on campuses. The Department of Health has accepted the temporary arrangement during the current bushfire risk.
- Implications of a recent Supreme Court judgement on management by universities of allegations of criminal behavior. It will be necessary for Griffith to review its policies should The University of Queensland's appeal be unsuccessful.
- The draft Policy on Academic Freedom and Freedom of Speech has been circulated to staff for feedback, and on-campus staff consultation sessions were subsequently conducted in late November by Professor Emeritus Lesley Chenoweth AO. Feedback from staff will be considered and the draft policy will be reviewed by Executive Group in late January, for subsequent recommendation to February Council.

### **UNIVERSITY BUDGET 2020-2025**

Council **resolved to adopt** the 2020-2025 Griffith Budget. Achieving financial sustainability while enabling the Griffith Strategy: Creating a Future for All (2019/0000145).

#### **2020 CAPITAL MANAGEMENT PLAN**

Council resolved to approve the 2020 Capital Management Plan (2019/0000146).

## **LOGAN CAMPUS MASTER PLAN**

Council **resolved to approve** Section 5 of the Logan Campus Master Plan (2019/0000144), excluding the proposed EcoCentre.

Council noted the four proposed precincts in the Logan Campus Master Plan - Academic Heart, Sport and Recreation, Residential and Commercial; and Partnership – were intended to maximise campus utility, facilitate integration and retain green space. The Vice Chancellor advised members that a clear purpose and intent would support the Logan campus to respond to and engage with partnership opportunities as they arose.

## **DRAFT 2020-2025 STRATEGIC PLAN KEY PERFORMANCE INDICATORS**

Council provided feedback on the draft key performance indicators (KPIs) developed following approval of the *Creating a future for all – Griffith Strategic Plan 2020-2025*. Council noted that the

final draft KPIs together with respective measures and targets would be submitted to the February 2020 Council meeting for consideration and approval.

#### **GUIDELINES TO COUNTER FOREIGN INTERFERENCE IN THE UNIVERSITY SECTOR**

The Vice Chancellor briefed Council on the recently released *Guidelines to Counter Foreign Interference in the Australian University Sector* and provided an overview of Griffith's current state and steps to be taken to assure the security and integrity of Griffith's people, information and assets.

### **ACHIEVING NET ZERO CARBON EMISSIONS BY 2050**

Council endorsed the report entitled 'Achieving Net Zero Carbon Emissions by 2050' (2019/0000147)

Council noted that a key action of the *Creating a future for all Strategic Plan 2020-2025* was to develop an action plan to align Griffith with the recommendations of the Intergovernmental Panel on Climate Change by halving carbon emissions by 2030 and reducing them to zero by 2050. It was noted the endorsed report concluded the reduction target was achievable with targeted new investment and appropriate planning.

#### **GRIFFITH FILM SCHOOL CHANGE PROPOSAL**

Council resolved to approve with effect from 1 January 2020 that the Griffith Film School separate from the Queensland College of Art to become an independent school; and that the Head, Griffith Film School title change to Director, Griffith Film School.

#### **STAFF APPOINTMENT**

On the recommendation of the Vice Chancellor, Council **resolved to approve** that Professor Ruth McPhail be offered a further appointment as Head, Department of Employment Relations and Human Resources for a three-year period from 1 January 2020 up to 31 December 2022.

### PRESENTATION: INTERNATIONAL STUDENT RECRUITMENT AND EXPERIENCE

Professor Sarah Todd, Vice President (Global) delivered the 2019 Internationalisation Update to Council. The briefing focused on key recruitment trends, recruitment initiatives and the student experience.

## **AMENDED ACADEMIC COMMITTEE CONSTITUTION**

Council **resolved to approve** with immediate effect an amended constitution document (2019/1001103) to update the membership provisions to include a Vice President membership category and a new member position for a First Peoples' Student Representative.

### **COUNCIL MEMBERSHIP**

Council noted the term of office of additional members, Dr Robert Anderson OAM and Ms Sandra Anderson, would conclude on 31 December 2019 and this was the final meeting they would attend. Council resolved to place on record its appreciation of the long service and significant contributions of Dr Anderson and Ms Anderson to the work of Council and its committees.

Council congratulated Mr Craig Bassingthwaighte and the Hon Robert Borbidge AO on their reappointment as additional members for a further one-year term of office from 1 January 2020 up to and including 31 December 2020. It was noted that Mr Joshua Creamer and Ms Jessica Rudd would commence three-year terms as additional members from 1 January 2020.

Council welcomed Mr Srinath Chithravelu Poochan (preferred name CP), elected postgraduate student, and Mr Liam Baker, elected undergraduate student to their first meeting. Members noted the student members had recently been elected to Council for two-year terms commencing from 28 October 2019 up to and including 27 October 2021.
