- Who makes decisions about what happens in my family and will I get a say in this?


 Questions from the Child Harmed:

- How do I support both of my children in this when they have very different needs?
- When can my kids see each other again?
- Will this ever be overs

COLLABORATION IN PRACTICE

Communication:

Common language; remaining open; transparency; acknowledging differences

Professional trust, respect, responsibility and accountability; recognising privilege

Collaborative Processes:

 Interagency meetings; clarity of roles; collaborative decision making and case planning; interagency family sessions

Organisation Processes:

Framework for addressing SHSB: support for interggency collaboration: supervision; professional development

"It should be standard practice to use a collaborative, multi-agency approach to deliver promising and preferred treatment that focusses on holistic, eco-systemic and family/caregiver elements that support the [child], young person and their family.
