Climate politics in Oceania

In a thought-provoking and insightful panel discussion, the launch of Climate Politics in Oceania: Renewing Australia-Pacific Relations in a Warming World sparked a crucial conversation on the urgent need for renewed climate leadership in the Oceania region. Held on 11 April, the event brought together prominent figures in academia and advocacy to address pressing issues surrounding climate change and diplomatic relations.

The panel featured Professor Susan Harris Rimmer and Dr Wesley Morgan as co-editors, alongside Associate Professor Tess Newton Cain as an author and Mary Maselina Harm as a respondent. Together, they provided compelling insights into the complex dynamics shaping Australia-Pacific relations amid the escalating climate crisis. Discussions highlighted the need for stronger policy commitments, enhanced regional cooperation, and greater recognition of Pacific voices in climate diplomacy. The event underscored the urgency of action and the responsibility of Australia to engage meaningfully with Pacific nations on climate justice.

Can deliberation bridge divided publics? A hopeful story from the Philippines

Have social media users in the Philippines lost their free will to disinformation, or are they willingly complicit in spreading false narratives online? In this presentation, Professor Nicole Curato from the Centre for Deliberative Democracy and Global Governance at the University of Canberra, provided a hopeful pathway to break free from narrow and damaging portrayals of social media users in a country often described as the "patient zero" of the global disinformation epidemic.

Drawing on a decade of academic research on democratic innovations in the Philippines, Nicole identified plausible projects that can transform the public sphere at a time of authoritarian nostalgia, impunity, influence operations, and information disorder.



How Australia can harness the power of sport for good at home and across the region

On 2 June 2022, the Perspectives: Asia lecture series featured Stephanie Brantz, freelance media professional, and Nikki Dryden, former Olympic athlete and human rights lawyer, in a discussion on sport's role in advancing human rights.

With Australia set to host several Mega Sporting Events in the next decade, the speakers highlighted the nation's opportunity to lead in sports diplomacy and human rights. While individual Australians have been global human rights advocates, Australia as a nation has yet to take a leadership role in this space.

The discussion emphasised the need for international collaboration and a deeper understanding of human rights to harness sport as a tool for social change in the region. By building on its sporting legacy, Australia could shape a global agenda at the intersection of sport and human rights, strengthening communities across the Asia-Pacific.

What happened in Wuhan?

Moderated by Professor Caitlin Byrne, , the 22 July Perspectives: Asia lecture featured Chris Buckley, China correspondent for The New York Times, in an online discussion reflecting on China's handling of the COVID-19 outbreak in Wuhan.

Chris shared insights from his five months in Wuhan, including two and a half months under lockdown, providing a first-hand account of the Chinese government's response to the crisis. He examined how authorities managed the outbreak and the broader social and political implications of the world's first COVID-19 lockdown.

Having spent 24 years in China as a journalist, Buckley also discussed his reporting on China's political landscape and human rights issues, including the crackdown in Xinjiang. Now based in Sydney after being forced to leave China, he was among the New York Times journalists whose work won the Pulitzer Prize for Public Service in 2021.















Role of press freedom as a pillar for democracy

An online discussion on the state of global press freedom featured Stefan Armbruster (SBS World News), Marites Danguilan Vitug (Rappler) and Professor Peter Greste (University of Queensland), and Scott Waide (EMTV News).

The panel explored the increasing restrictions on media freedom worldwide, highlighting the politically motivated conviction of Rappler journalists Maria Ressa and Reynaldo Santos Jr. in the Philippines. The discussion underscored how press suppression, once limited to authoritarian regimes, is now spreading to established democracies, threatening journalistic integrity, public trust, and democratic institutions.

Each speaker shared their experiences in journalism, reflecting on media challenges in Australia, the Pacific, and Southeast Asia. With press freedom at historic lows, the conversation emphasised the urgent need to safeguard independent journalism as a cornerstone of democracy. The event was chaired by Stefan Armbruster, an Industry Fellow at the Griffith Asia Institute.

Japan: From Heisei to Reiwa

On 30 May 2019, former Australian Ambassador to Japan, Bruce Miller AO, delivered a Perspectives: Asia lecture reflecting on Japan's imperial transition from the Heisei to Reiwa era.

Miller highlighted Japan's continuity in imperial tradition, noting that while Emperor Akihito's abdication was historically significant, the transition did not bring major political changes. He discussed the Emperor's constitutional and religious roles, as well as the Imperial Family's cultural and humanitarian contributions, particularly in times of crisis, such as the 2011 earthquake and tsunami.

Looking ahead, Miller examined Japan's economic and strategic challenges, including trade liberalisation, demographic shifts, and regional security threats. He also emphasised the country's enduring social stability, low crime rates, and world-renowned service culture.

With deep expertise in Japanese history and policy, Miller provided valuable insights into Japan's future trajectory in the Reiwa era within an evolving geopolitical landscape.



Blood and silk: Power and conflict in modern Southeast Asia

In this seminar, Michael Vatikiotis, discusses his book *Blood and Silk: Power and Conflict in Modern Southeast Asia*. As a writer, journalist, and diplomat with over 30 years of experience in the region, Vatikiotis offered a compelling analysis of the power struggles and conflicts shaping Southeast Asia today.

Drawing from his direct involvement in peace negotiations, he examined the deep-rooted issues of corruption, insurgency, and religious division in countries such as Indonesia, Malaysia, Myanmar, and the Philippines. He also explored China's expanding influence and its impact on regional stability. Peering beyond modern skyscrapers and economic progress, Vatikiotis painted a vivid portrait of the personalities and forces that drive political and social tensions. His insights provided an engaging and thought-provoking look at one of the world's most dynamic and complex regions.

Australian sports diplomacy in the Pacific

On 14 September 2017, the Perspectives: Asia seminar explored the role of sport in diplomacy. Moderated by Professor Caitlin Byrne. The discussion examined how sport and athletes can enhance diplomatic outcomes, strengthen people-to-people connections, and promote cultural, trade, education, and tourism opportunities.

The seminar featured insights from Aaron Alsop, Director of High Performance Sport at the PNG Sports Foundation; Amelia Kuk, a former Rugby 7s player; Andrew Minogue, Chief Executive Officer of the Pacific Games Council; and Timothy Walsh, coach of Australia's first Women's Rugby 7s Team. Drawing from their professional and personal experiences in Australia and the Pacific, the speakers highlighted sport's unique ability to bridge cultural divides, foster international engagement, and showcase Australia's identity, values, and influence in the region. The discussion reinforced the growing role of sports diplomacy in strengthening Australia's regional partnerships.



Empowering women: Advocacy through art

On 15 August 2016, the Perspectives: Asia lecture series featured Empowering Women: Advocacy through Art, presented by Her Excellency Mrs Naela Chohan, High Commissioner of Pakistan to Australia. The event highlighted the intersection of art, diplomacy, and advocacy in promoting women's empowerment across Australia, Pakistan, and the broader region.

Mrs Chohan shared insights into how her dual roles as an artist and a diplomat enabled her to engage communities and foster dialogue on gender equality. She discussed the power of artistic expression in amplifying women's voices, raising awareness of their struggles, and celebrating their achievements. Through her artwork and diplomatic initiatives, she sought to challenge societal norms and advocate for greater opportunities for women.

The lecture provided a compelling exploration of how cultural diplomacy and the arts can serve as powerful tools in advancing social change, strengthening cross-cultural understanding, and promoting gender equity on a global scale.

On 19 May 2015, Professor Tim Lindsey delivered a compelling Perspectives: Asia lecture titled 'Preposterous Caricatures': Why is the Australia-Indonesia Relationship So Difficult? The event explored the complexities of the bilateral relationship between Australia and Indonesia, highlighting the significant differences in language, culture, history, ethnicity, and religion that shape their interactions.

Professor Lindsey examined how mutual misunderstandings and entrenched stereotypes—what former Indonesian President Susilo Bambang Yudhoyono termed "preposterous caricatures"—continue to strain diplomatic ties. He discussed the persistent lack of awareness among Australians and Indonesians about one another, compounded by a decline in "Indonesia literacy" in Australia. He also addressed Indonesia's growing economic influence and its aspirations for a greater regional role, presenting new challenges for Australia.

Drawing on historical and recent bilateral crises, Professor Lindsey provided an insightful analysis of the evolving dynamics between the two nations, underscoring the need for deeper engagement and mutual understanding.



Report of the Commission of Inquiry on human rights in the Democratic People's Republic of Korea

On 1 May 2014, the Perspectives: Asia seminar featured The Hon Michael Kirby AC CMG, who led the United Nations Commission of Inquiry into human rights abuses in North Korea. The report, released in February 2014, exposed severe violations, including forced labour camps, systemic repression, and political persecution.

Justice Kirby discussed the historical context of North Korea's unique political system and the challenges of Korean reunification. He highlighted the Commission's innovative methodology, which relied on public hearings and testimonies from North Korean escapees.

A former High Court Justice, Kirby is widely recognised for his contributions to social justice and international human rights. Since retiring in 2009, he has remained active in global human rights initiatives, receiving numerous accolades, including the Gruber Prize for Justice. His work continues to shape international legal responses to human rights violations.

Blackbirding, South Sea Islanders and seasonal workers: Historical memory and contemporary justice across the Pacific

On 16 August 2013, the Perspectives: Asia seminar explored the legacy of blackbirding and its ongoing impact on Pacific communities. The event featured The Hon Ralph Regenvanu MP, Minister for Lands, Geology and Mines in Vanuatu, and journalist Nic Maclellan, with veteran Pacific correspondent Sean Dorney as chair.

Marking 150 years since the colonial labour trade began, the discussion examined how over 60,000 Melanesians were brought—often through coercion—to work in Australian industries like sugar and cotton between 1863 and 1904. Many were later deported under the White Australia Policy, while others remained in Queensland and northern New South Wales.

Today, Australian South Sea Islanders (ASSI) are reclaiming their history and forging connections with communities in Vanuatu, New Caledonia, and the Solomon Islands, ensuring that their ancestors' stories are remembered and their rights recognised.



Queensland and China in the 40th anniversary year of the Australia-China relationship

On 8 November 2012, Her Excellency Ms Frances Adamson, Australian Ambassador to China reflectied on four decades of Australia-China diplomatic relations. On 20 October 2011, The Hon Julie Bishop MP, Deputy Leader of the Opposition and Shadow Minister for Foreign Affairs and Trade, delivered a Perspectives: Asia lecture on Australia-Asia Relations.

In her address, Ms Bishop examined Australia's evolving relationships with key Asian nations, emphasising the region's growing economic and strategic importance. She highlighted the necessity of strong diplomatic engagement, trade partnerships, and cultural exchange to secure Australia's place in an increasingly interconnected Asia-Pacific.

She underscored the importance of deepening ties with major economies such as China, India, Japan, and ASEAN nations while maintaining strong alliances with traditional partners.

Her speech reinforced the view that Australia's future prosperity is closely linked to Asia, advocating for policies that support economic integration, security collaboration, and mutual understanding between Australia and its regional neighbours.



Australia-Japan relations: The current state of the relationship – existing and future challenges

On 27 October 2010, a Perspectives: Asia event featured a discussion on Australia-Japan Relations: The Current State of the Relationship – Existing and Future Challenges, jointly presented by His Excellency Mr Shigekazu Sato, Japanese Ambassador to Australia, and The Hon Alexander Downer.

Ambassador Sato provided a historical overview of Australia-Japan relations, highlighting Queensland's early role in forging ties, from Japanese migration in the 19th century to labour contributions in the pearling and sugar industries. He reflected on postwar economic cooperation, including the 1957 Japan-Australia Commerce Agreement, which underpinned decades of strong trade relations.

Acknowledging the rise of China as Australia's largest trading partner, Ambassador Sato emphasised Japan's ongoing significance, particularly for Queensland. He also discussed regional security concerns, including China's increasing assertiveness in the Asia-Pacific. The lecture underscored the need for continued bilateral cooperation on economic, strategic, and environmental issues to ensure stability and prosperity in the region.






