

25.00 Signage

The requirements of this Section are Mandatory.

25.01 Generally

This Section defines the signage requirements, both Statutory and General, required on all projects for GU.

Refer to the Project Signage Schedule contained in 'Appendix A' to this Section for details of signage types, responsibility for supply and installation and the general location of signs.

The Head Consultant or Contractor must consult with and seek the approval of CLF on the extent and type of all signage to be installed in the project prior to finalising the tender documentation or the Total Project Sum.

25.02 Statutory Signage

The Contractor shall supply and install all Statutory signage in accordance with the requirements of the BCA.

25.03 Braille & Tactile Signage

Braille and tactile signage shall be used where required by the BCA.

All signs including directory boards that are within normal reach, shall be Tactile signs except where nominated later in this Section, stated on the Standard Signage Drawings or directed by CLF.

25.04 Room Signage

Room numbers and names mounted in aluminium holders as detailed on GU Standard Signage Drawings GSS – 200 and 202, shall be adhesive fixed into the holder with clear silicone to prevent unauthorised removal unless otherwise advised by CLF.

25.05 Hanging Signage

Hanging signs shall be used to provide clear and unobstructed directional signage at corridor entries, junctions and the like.

The use of Hanging signs for other applications shall be to the approval of CLF.

All Hanging signs shall be in accordance with GU Standard Signage Drawing GSS – 303, and all content shall be subject to the approval of CLF.

Care must be taken to ensure that hanging signs do not obstruct Emergency Exit signage.

25.06 Vinyl Signs

Signs created with vinyl letters fixed direct to the background, shall be in accordance with the requirements of GU Standard Signage Drawing GSS – 310.

Where vinyl signage is fixed on glass panes to doors and partitions, the colour of the lettering shall be selected to provide adequate contrast against background colours.



In addition to the requirements of GU Standard Signage Drawing GSS – 208, 'Push' and 'Pull' signs are required to all doors in public spaces and to Lecture Theatres.

25.07 Perspex Signs

Signage other than that specifically detailed in the GU Standard Signage Drawings, shall comply with the requirements outlined on GU Standard Signage drawing GSS – 310, comprising vinyl lettering reversed on the back of a clear or backsprayed white Perspex panel, all to the approval of CLF. All corners of the panel shall be radiused, and the sign shall be fixed to walls with 6mm anchor fixings and ss acorn nuts.

25.08 Special Signage

Signage to reception counters for Schools, Departments, Research Centres and the like shall be designed by the project architect in consultation with CLF and users.

Such signage may be mounted on bulkheads over counters or on walls adjacent to or behind the counter. Illumination of the signage shall be achieved by the use of directional light fittings, not by the use of light boxes or neon tubing.

In designing such signage, consideration must be given to the removal or modification of the lettering without causing significant damage to the wall or bulkhead surface.

Signage required to identify hazards and safety issues with respect to laboratories or other specialist areas, shall be determined in consultation with the relevant School WH&S officers.

25.09 External Signage

Unless otherwise advised by CLF, all external signage around buildings shall be the responsibility of GU.

25.10 Building Sign

The Contractor shall supply and install the building number and name in the location determined in accordance with the requirements of **Section 8.00** External Walls. Refer to GU Standard Signage Drawing GSS – 266 for details of the lettering style, size and fixing details.

The building number and name shall be supplied by CLF.

25.11 Toilet & Amenities Signage

Toilet and amenities signage shall be "Visualise" – anodised aluminium range with fixing plates – manufactured by Pitt & Co (Aust) Pty Ltd or equal approved.

Signs shall identify features within the toilet/amenity. Multiple features shall be incorporated on one sign and shall be approved by CLF.

Fixing plates shall be fixed to walls with Ramset or equal approved – "Hollow Wall Anchors" for plasterboard and "Nylon Anchors" for masonry.

Install in accordance with the BCA and GSS-218 Rev 0.
